High up on the Franschhoek Pass overlooking one of the most beautiful valleys in the world, lies Haute Cabrière Estate. Built into the side of the Franschhoek mountain range, Haute Cabrière features a unique ceremonial venue with soaring cathedral-like arches, flanked by French oak barrels where our Pinot Noir rests in maturation. Complete with rows of seats down the aisle where your guests come to celebrate your marriage, this venue sets the tone for an unforgettable experience. The festive character of Haute Cabrière is rounded off by our range of elegant wines and a fine dining environment at Haute Cabrière Cellar Restaurant, which is situated just above the

barrel maturation cellar and dressed in crisp, white linen, lit up by white chairs and beautiful sparkling handcrafted chandeliers.

## OUR VENUES

A variety of venues are available to make your special day a unique experience for everyone. We are more than happy to show you the facilities and to share our own experiences with you to create a smooth flow for your celebrations. The cathedral-like Pinot Noir Barrel Maturation Cellar is a beautiful venue for your ceremony, and can accommodate up to 100 guests. Our hand-made French Oak Barrel chairs are included in the arrangements. After the ceremony, guests move upstairs – weather permitting - to enjoy pre-drinks and canapés on the Terrace overlooking the Franschoek valley. For your festive meal and dance, Haute Cabriere Cellar Restaurant offers the “true marriage of food and wine”. A range of set menus is available for you to choose from. We are also more than happy to accommodate any other requests. The venue can seat up to 100 guests, while still allowing space for a dance floor. For larger groups, the venue can be extended at an additional fee (see below).

Please also note the following:

- Haute Cabriere Cellar Restaurant is wheelchair friendly.
- Our Helicopter Landing Pad is also a popular option to explore when attending your special event. If you are interested, please enquire about the terms and conditions.

# TERMS & CONDITIONS

## BOOKING CONFIRMATION & DEPOSIT

- Provisional dates will be kept for seven days from the date receiving your booking.
- A 50% deposit of the venue fee is required within seven days of making your booking in order to secure your date. This deposit is non-refundable.
- Your date will be released if deposit and signed contract are not received within the seven day period.
- The final number of guests, meal choice and dietary requirements need to be confirmed 14 days prior to the event. At the same time, we require a 100% pre-payment of your meal account.
- Once your date has been confirmed and deposit paid, you will not be able to move this date without paying the relevant cancellation fee. However, your deposit will be retained for the new date.

## FINAL PAYMENT

- We require the 50% balance of the venue fee within 60 days prior to the event taking place.
- We require the full pre-payment to be via EFT using your surname as reference.
- A 5 day payment grace will be given on a short notice booking.
- Any additional charges and fees, such as your beverages, early arrival or set up fees, etc. need to be paid within 24 hours after the end of the function. Thereafter we will automatically charge the amount to your credit card.

## CANCELLATION POLICY

You agree to settle any penalties or cancellation fees regarding venue fees as well as food and beverages, which may be levied as a result of total cancellation. The following amounts will be charged:

- More than 60 days prior to arrival: 50% deposit of venue fee.
- 60 - 22 days prior to arrival - 100% of the total venue fee.
- 21- 07 days prior to arrival - 75% of the total value of the venue fee AND meal account.
- Less than 07 days prior to arrival - 100% of the value of the venue fee AND meal account.

In case of full cancellation, the cancellation fee will bear interest of 1% above prime rate per month until paid.

## **PRICES, FEES AND OTHER CHARGES**

- All prices, rates and fees are quoted in South African Rand and inclusive of 14% VAT.
- All prices, rates and fees are valid for functions held between 01 September 2011 and 31 August 2012 and are subject to change without prior notice.
- A 10% service fee will be charged to your food and beverage account.
- Venue fees do not include any beverages, canapés, meals, carpet rentals, decoration, overtime charges, early arrival or set up fees, or any other services.

## **LIABILITY**

Clos Cabriere Ltd. accepts no responsibility for:

- Any loss, damage or injury to client, their guests or any of their belongings.
- Inclement weather affecting functions booked outdoors. It is the responsibility of the client to ensure a back-up venue has been arranged.
- Inability to perform due to power outages, strikes, or natural disasters.

The client, his/her guests or employees will be liable for any damage or injury caused to Clos Cabriere Ltd. and/or its employees.

If any incident related to the function results in legal involvement of a third party, the client will exclude Clos Cabriere Ltd. and its employees from all responsibility or blame.

Items delivered by the client for the function are the client's responsibility, and should be collected by 11h00 the next morning, unless other arrangements have been made. Otherwise, Clos Cabriere Ltd. will dispose of these items as we deem fit.

## **FUNCTION TIMES**

- Unless otherwise agreed and confirmed in writing at least 30 days prior to the event, both the barrel maturation cellar and Haute Cabriere Restaurant are available for evening weddings any time from 17h30 (arrival time for guests).
- It is the client's responsibility to obtain written confirmation of these arrangements.
- A surcharge of R 6 000 will be levied if the arrival time is prior to 17h30.
- Our liquor license is valid until 02h00, therefore last rounds are served strictly at 01h30.
- The venue is available until 02h00.

## SEQUENCE OF EVENTS

- A document outlining the sequence of events for the reception will be drawn up by Clos Cabriere and must be agreed in writing at least 7 days prior to the reservation date.
- Unfortunately, we cannot allow any changes to the sequence of events once they have been agreed in writing.

## MENU ARRANGEMENTS

- Note that all menu items are subject to change.
- We do not allow any choices between dishes from our menu selector. Please select a 3-course meal.
- An additional course may be selected with a surcharge applicable. This will be confirmed with you on your selection.
- Please advise us of any dietary requirements 14 days prior to the event.
- Your menu choice must be confirmed at the latest 14 days prior to the event.

## BAR ARRANGEMENTS

- A cash bar facility is available at an additional cost of R2 500.
- We offer a limited range of beers and spirits. This will be confirmed with you on enquiry.
- Last rounds strictly at 1.30pm.
- Full payment of the bar account is required on the evening. We do not carry any accounts.
- Any outstanding accounts that may occur will be charged to the client.
- We do not allow any "bring your own" arrangements.

## DECOR AND SETUP

- All decoration arrangements must be agreed and scheduled with Clos Cabriere Ltd. well in advance.
- All flower arrangements and other decor is to be organised by the bridal couple. Haute Cabriere staff cannot assist the florist or any other decor person with decorations, lighting of candles, carrying of material or moving flower arrangements either during set-up or later during the evening.
- We have a list of suppliers to assist you with the planning of your special day, including florists, marriage officers, musicians, etc.
- The restaurant can be set up decorated from 15h00 on the day of the event. Should you wish to start your decorations prior to this time, an additional charge applies, allowing you to set up from 9h00 in the morning. Early set up charges as follows:
  - R 9 000: 01 May 2012 – 31 August 2012
  - R 6 000: 01 September 2011 – 31 April 2012.
- The barrel maturation cellar may be decorated from 15h00 on the preceding Friday for a Saturday event.

- No candles, flowers or other decorations are allowed on the wine barrels.
- No rose petals, confetti or feathers are allowed in the vinoteque or cellar.
- Clos Cabriere Ltd. does not take responsibility for loss or damage to decorations or belongings.
- All decor must be removed from the restaurant and cellar by not later than 11h00 the following day. Otherwise, the restaurant will dispose of any items as it sees fit.

## SMOKING

In accordance with South Africa's legislation, Haute Cabriere Cellar Restaurant and the Barrel Maturation Cellar is a strictly non-smoking venue.

## CHILDREN

Children are welcome if parental supervision is maintained at all times with responsibility for safety and well being resting with the parents. Clos Cabriere Ltd. is unable to provide childminding services.
